PRIVACY AND COOKIE POLICY 1.INTRO

1.1. Welcome to Canvas Hamlet's Privacy and Cookies Statement. You might be viewing this through our website or mobile application (which we'll collectively call our "Platform" for short).

1.2.We care about being transparent with you about what information we collect when you choose our events and how we use that information. It's important to us that we give you as

1.4.In this Privacy and Cookies Statement, when we refer to "you" and "your" we mean you, the person using the Platform or staying at Canvas Hamlet or otherwise interacting with us.

3.ABOUT US

2.1.If you yourself are under 18, you must have the permission of your parent or legal guardian ("Your Adult") to use our Platform and only Your Adult will be able to purchase book a glamping structure. You should also make sure that Your Adult reads this Privacy and Cookies Statement.

4.INFORMATION WE MAY COLLECT ABOUT YOU

3.1.We are Canvas Hamlet, a company incorporated in England and Wales. Our company number is 13140412. Our registered address is Unit 1, Cilmedw Way, Llangollen, LL208AG.

5.INFORMATION WE COLLECT FROM YOU DIRECTLY

5.1.1.If you register for one of our newsletters or request any advance information about our services, we will collect your name and contact details.

5.2.Purchases

5.2.1.If you make a purchase with us (whether a glamping structure or any other goods and/or services) we'll collect any information necessary to provide you with your purchase. For

5.2.2.we'll typically ask for your name, email address, ages of those in your party (if booking a family holiday) and payment details so we can process your purchase.

5.2.3.We'll collect information about any particular requirements you may have in order to gain access to our glamping site: this may mean providing us with information about your physical health or similarly sensitive information;

5.2.4.If there are circumstances where we need to verify your age for entry to our glamping site or for fraud prevention and detection, we will ask for proof of identity and age (such as a

5.2.5. We may (if applicable), collect additional information specifically relevant to the goods and/or services that you are purchasing. For example: if you buy a gin tasting experience, we may ask you to provide proof of age.

5.3. Promotions and Surveys 5.3.1. Every now and again, we might invite you to participate in competitions, promotions or surveys. We'll collect information so you can participate in these and deliver the prize if you win: this will include details such as your name, age and email address and any other information you provide in connection with your promotion entry and/or survey response.

5.4. Health and welfare 5.4.1.If you ever need to visit one of the health and welfare facilities at one of our glamping sites, you might need to give certain health or medical information which may be considered

sensitive information. Sometimes, these services will be managed by a third party and not us, in which case we won't have control or visibility of the information you give and this Privacy and Cookies Statement won't apply. 6.INFORMATION WE COLLECT FROM YOU INDIRECTLY

6.1.Communications

6.2.IP address and device information 6.2.1. We will collect certain technical information about your device visits to our Platform and how you use the Platform. This may include your IP address, geographical location, device

details such as your IMEI number, the MAC address of the Device's wireless network interface), browser type, referral source, length of visit, operating system, number of page views and similar information. This information may be collected by a third-party analytics service provider on our behalf and/or may be collected using cookies. For more details about cookies

6.3. Cashless payment wristbands at our Events 6.3.1.If cashless payment wristbands (or other similar technologies) are used, they will allow you to make cashless payments (such as food and drink) and/or provide you with access (such as entry to the festival or VIP areas). If you use a cashless payment wristband, we may collect certain information about your interactions at, and engagement with, the glamping site and

our partners. For example, we may know which partners you visited and what purchases you made on site. We do this to provide you with a more enhanced experience

6.4. Email Response Information

6.4.1. We might collect information about how you react to the emails we send to you, for example, how many times you open the email or if you engage with its content (for instance, by clicking on any links within it).

6.5. Social Media and Information you post online and reviews

6.5.1. We might collect information relating to any social media posts or comments you share online about our glamping sites that are in the public domain (for instance, if you leave a review about on a third-party social media site like Facebook). If you leave a comment or review on one of our social media official pages (such as through our Facebook, twitter or Instagram accounts), we may use this information to respond to your posts. We are not in control of these third-party platforms and you should refer their privacy notices if you want to know more about how they use the information you share online

7.INFORMATION WE GET FROM THIRD PARTIES 7.1.Booking agents and service providers

7.1.1. We will collect information about you from third parties that we work closely with so we are able to deliver the goods or services you have requested. For example, we might work with a booking manager or online travel agent who will sell a package for Canvas Hamlet. In those circumstances, they might give us your details so we can provide you with access to our glamping site, or other ancillary services. We might also use third-party companies to manage our payment systems or Platform, they may collect information directly from you on our behalf.

8.2.4.we might contact you by phone to offer assistance if you have entered your contact details on our Platform but have not completed your purchase;

8.2.5.to improve and update our Platform and to make sure that content from our Platform is presented to you in the most effective and optimal manner (please view the specific Cookies section for more information);

8.2.6.to carry out aggregated and anonymised research about general engagement with our Platform and other goods and services; and

8.2.7.to allow us to monitor access to, and attendance at, our glamping sites for health, safety and security purposes. Marketing Purposes
